SCIENTIFIC COOPERATION CONVENTION

Between:

Research, Development and Testing National Institute for Electrical Engineering - ICMET (hereinafter ICMET) having the headquarters in Craiova (Romania), Calea Bucuresti 144, represented by Dipl. Eng. Marian Duţă

and

SICOM Test srl having the headquarters in Trieste (Italy), Padriciano 99 ((hereinafter SICOM) represented by Dott. Roberto Passini

The contracting parties agree to:

ARTICLE 1 - Object

The object of the present scientific cooperation agreement is to define the general conditions of cooperation between ICMET and SICOM

ARTICLE 2 - Fields of Application

Cooperation, object of the present agreement refers to problems concerning: The test and certification in the field al Radio Frequency and Human Exposure to EMF.

The fields of cooperation will be detailed in a periodic program and can be herein extended.

ARTICLE 3 - Forms of Cooperation

- 3.1. The program of activities will be settled and brought up to date periodically. The two parties engage to use all means to achieve this program within the agreed time.
- 3.2. Cooperation, object of the present agreement, can have among other things the following forms:
- 3.2.1. Testing and certification activities;
- 3.2.2. Settlement of relationships with the scientific promotion bodies;
- 3.2.3. Personnel mobility (staff exchange);
- 3.2.4. Training of scientific collaborators;
- 3.2.5. Assistance in the research works;
- 3.2.6 Test methods and test systems development.
- 3.3. The actions provided by articles 3.2 can be the object of some special conventions determining the methods and financial conditions to carry them out.

ARTICLE 4 - Coordination

- 4.1. To put into practice the cooperation, object of the present agreement each party will appoint a coordinator.
- 4.2. These coordinators of the parties are enabled by the signatory authorities to:
 - -determine the main cooperation directions and propose the program priorities;
 - -establish yearly a calendar of the actions proposed in the program and their price too;
 - -evaluate yearly the achievement of the agreed program.
- 4.3. The coordinators will meet yearly in each participant country alternatively.
- 4.4. The two parties agree to appoint Mr.A.Marinescu and Mr.R.Passini respectively as coordinators.

ARTICLE 5 - Methods to Achieve the Cooperation

- 5.1. The two parties will inform one another of all useful documents and information as far as they will be able to dispose of them on the condition of observing the confidentiality rules.
- 5.2. For the actions provided by articles 3.2 the parties will facilitate the access to documents and installations for the staff they will enable.

ARTCLE 6 - Financial Conditions

6.1. The actions provided by articles 3.2 will be financed by the two parties according to the methods that will be settled on a case by case basis or within the programm of activities.

ARTICLE 7 - Confidentiality, Industrial Property

- 7.1. The parties engage to keep rigorously the confidential character of the technical information and documents coming from the other party and to impose the observance of these rules to the persons or bodies liable to intervene in the present cooperation.
- 7.2. The information and technical documents exchanged by the parties shall not be communicated to a third party.
- 7.3. The publications concerning the activities achieved by the two parties in common shall be authorized by both of them.

ARTICLE 8 - Convention Time, Cancellation

- 8.1. The present agreement will come in force on the date when the two parties sign it.
- 8.2. The convention will remain in force for a four (4) years period starting from this date and will be tacitly extended.

- 8.3. The present agreement will be able to be cancelled anytime by any of the parties by a previous notice of three months in written form.
- 8.4. If this agreement is cancelled, the specific agreements mentioned at article 3.2 will remain in force during the time period necessary to achieve them completely, if the two parties do not decide otherwise.
